Face Coverings

Last month, President Robbins announced the following Directive that applies to all faculty, staff, students, designated campus colleagues, and visitors to University of Arizona campuses or locations.

Locations Where Face Coverings Are Required Regardless of Vaccination Status

You are required to wear a face covering, regardless of vaccination status, when you are:

- In any indoor classroom or other group instructional setting and in any University library
- In a CatTran or any other public transportation provided by the University
- In any University operated or affiliated building or facility where patients are seen, including Campus Health and Banner University Medical Center buildings
- At the University of Arizona state of Arizona Vaccine Point of Distribution (POD)
- At sites operated by other institutions that require use of face coverings

Fully Vaccinated Individuals:

Once fully vaccinated, you can participate in indoor and outdoor activities without wearing a mask or physically distancing, except for when you are at the locations identified above.

Fully vaccinated individuals who are immunocompromised, including those undergoing transplant or cancer treatment, should seek the guidance of their clinical care team before discontinuing mask use.

NOTE: You are considered fully vaccinated **two weeks after receiving the second dose of a two-dose vaccine**, such as the Pfizer or Moderna vaccines, or **two weeks after receiving a single-dose vaccine**, such as Johnson's Janssen vaccine.

Non-Vaccinated Individuals:

CLASSROOMS – You are required to wear a face covering in all classrooms and other group instructional settings.

INDOORS – You are required to wear a face covering in all university buildings, unless you are alone in a single occupancy office.

OUTDOORS – You are required to wear a face covering while in any University of Arizona outdoor space where continuous physical distancing of at least 6 feet is difficult or impossible to maintain.

Summer is here!


"The Heat Index, sometimes referred to as the apparent temperature, is a measure of how hot it really feels when relative humidity is factored with the actual air temperature.

To find the Heat Index temperature, look at the Heat Index chart below. As an example, if the air temperature is 96°F and the relative humidity is 65%, the heat index (how hot it feels) is 121°F.

IMPORTANT: Since heat index values were devised for shady, light wind conditions, exposure to full sunshine can increase heat index values by up to 15°F. Also, strong winds, particularly with very hot, dry air, can be extremely hazardous.

The Heat Index Chart shaded zone above 105°F shows a level that may cause increasingly severe heat disorders with continued exposure or physical activity."- Ambient Weather

As the temperatures are rising we ask that everyone be cautious outdoors and stay hydrated. Please see the heat index graph below which will also be posted on our website for reference.



COVID-19 Testing

As a friendly reminder, the UA COVID-19 Saline Gargle Wash PCR testing occurs every Wednesday from 8:00AM-1:00PM located on the UA-PBC Building 4, Room 115 (714 E. Van Buren Street, Phoenix, AZ 85006). Parking will be available and is free to all participants (see map below), please park near the front doors of building 4. Please note, in order to participate in the PCR SG testing, we ask that all participants do not eat/drink anything or brush their teeth 30 minutes prior to your test. Drinking water is okay.
